The following information summarizes our financial assistance programs: Patients may apply for financial assistance by submitting a financial assistance application with income information. Overlake Medical Center & Clinics use the federal poverty guidelines to help determine which financial assistance program best fits your needs.

Income is up to 300% of Federal Poverty Guidelines: After a financial assessment of the patient's income has been completed, the patient's bill will be reduced by 100 percent if their income level is at or below 300 percent of the Federal Poverty Guidelines.

Income is 301-400% of Federal Poverty Guidelines: After a financial assessment of the patient's income has been completed, the patient's bill will be reduced if their income level is between 301 percent and 400 percent of the Federal Poverty Guidelines.
